## **ADDITIONAL INFORMATION:**

On December 15, 1986, Roll Call 86-5702, the City of Des Moines, Iowa entered into a lease agreement with the Ruan Center, 666 Grand Avenue to house radio transmitters and receivers for the Public Safety Emergency Radio System. This lease expired in December 1996. A new lease was constructed in June 24, 1996 for ten years. This was approved by the Council on Roll Call 96-2296 and will expire in December 2006. A new lease has been completed and signed by the owner of the Ruan Center. The annual cost of the agreement will increase from \$7,369.44 to \$8,100. The new lease term is for another ten years and will expire December 31, 2017.

Currently, the City has WRA antennas and tornado alarms utilizing the site along with the police and fire departments. This transmitter site is and will remain an extremely valuable location to operate dependable and highly functional voice and data radio systems for the City. The expanding needs of public safety require continual evaluation of radio communication coverage and staff is continually working to improve voice coverage issues. Additional sites are being investigated to assist in the enhancement of our current system. These locations will require further review. The Ruan Center is an established transmitter site and will continue to be necessary to support our communication needs.
