Disposition Sale of 5208-5210 S.E. 6th Street, 5214-5216 S.E. 6th Street, 4901-4903 Meredith Drive, 4608-4610 49th Street, 4614-4616 49th Street, 4611-4613 49th Street, 4621-4623 49th Street, 4626-4628 49th Street, 4900-4902 N.W. 47th Avenue to Community Housing Initiatives, Inc.

SYNOPSIS:

Recommend approval to sell Des Moines Municipal Housing Agency disposition properties to Community Housing Initiatives, Inc.

FISCAL IMPACT:

Amount: \$838,350 from the sale and a five (5) year restrictive covenant of affordability.

Funding Source: Proceeds to be used in the following manner:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

ADDITIONAL INFORMATION:

The Housing Services Department received approval for its application to dispose of 394 Public Housing units at Fair Market Value, via a public bid on August 19, 2003. Where there is a commensurate public benefit, according to federal regulations, sales can be negotiated with a specific buyer.

Community Housing Initiatives, Inc. (CHI), an Iowa corporation has a long history of providing affordable housing in the state of Iowa, of meeting the requirements of federally funded housing programs and has the ability to meet the requirements of DMMHA's disposition plan. CHI, intends to use this property for housing opportunities for households below 80% of HUD median income guidelines.

DMMHA has received HUD approval for this negotiated sale.
