ADDITIONAL INFORMATION:

The Easter Lake Sanitary Trunk Sewer Connection Fee was established on September 16, 1996 by Roll Call No. 96-3213. The City of Des Moines entered into a Sewer Connection Fee Agreement and Covenant with the developer for Carman Estates Plats on October 6, 2003 by Roll Call No. 03-2317. The Agreement and Covenant were recorded in Book 10207, Page 122-127 with Polk County.

The Sewer Connection Fee Agreement and Covenant set forth the developer's commitments with respect to the deferred payments of the sewer connection fee, which was applicable to the properties described in the agreement. Section 5 of the agreement requires, as security for payment of deferred amounts, that all unpaid sums owed by the developer shall constitute a first lien against the developer's interest in favor of the City of Des Moines. Section 6 of the agreement requires that the City of Des Moines execute and deliver to the developer a release from the lien for properties being platted, upon payment of the applicable connection fee by the developer.

The City of Des Moines has received the applicable connection fees for the Carman Estates Plats, except for Outlot 'Z' of Carman Estates Plat 4 and Outlot 'Y' of Carman Estates Plat 5. Staff recommends approval of a Partial Release of Lien for the above-referenced properties, and direct the Legal

Department to bring back an ordinance authorizing the City Manager to execute Partial Release of Liens associated with any Sewer Connection Fee Agreement and Covenant.
