#### **AGENDA HEADING:**

Approving Final Plat for Woodside Estates West Plat Number 5 in Polk County.

#### **SYNOPSIS:**

Approval of the Final Plat for Woodside Estates West Plat Number 5 in Polk County, located north of NW 54<sup>th</sup> Avenue and south of NW 57<sup>th</sup> Place on either side of NW 3<sup>rd</sup> Court. The plat will have 24 residential lots zoned S, Suburban District. This plat is in the 2-mile review area the City has outside its City Limits.
