**AGENDA HEADING:**

Disposition Sale of 5209-5211 SE 6<sup>th</sup> St. to Community Housing Initiatives, Inc. (CHI)

**SYNOPSIS:**

Recommend approval to sell a Des Moines Municipal Housing Agency disposition property to Community Housing Initiatives, Inc.

**FISCAL IMPACT:**

Amount: \$88,125 in revenue from the sale and a five (5) year restrictive covenant of affordability.

Funding Source: FY 2006-2007 Operating Budget, Maintenance, SP350 HSG070000, pg. 225.

The proceeds from the sale will be used accordingly:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

**ADDITIONAL INFORMATION:**

The Housing Services Department received approval for its application to dispose of 394 Public Housing units at Fair Market Value, via a public bid on August 19, 2003. Where there is a commensurate public benefit, according to federal regulations, sales can be negotiated with a specific buyer.

Community Housing Initiatives, Inc. (CHI), an Iowa corporation has a long history of providing affordable housing in the state of Iowa, of meeting the requirements of federally funded housing programs and has the ability to meet the requirements of Des Moines Municipal Housing Agency's (DMMHA) disposition plan. CHI, intends to use this property for housing opportunities for households below 80% of HUD median income guidelines.

DMMHA has received HUD approval for this negotiated sale.
