AGENDA HEADING:

Hold hearing on proposed vacation of portions of 13th and Cherry Streets and on the conveyance of the vacated rights-of-way to Nationwide Mutual Insurance Company in accordance with the terms of a proposed Agreement for Exchange of Real Estate.

SYNOPSIS:

To accommodate the construction of Nationwide Mutual Insurance Company's (Donald V. Friert, Jr., Vice-President, Corporate Real Estate, One Nationwide Plaza, Columbus, OH 43215) proposed parking garage at 12th and Mulberry Streets, and to facilitate improved traffic circulation in the area, the City and Nationwide have negotiated a land exchange to assist both projects. The exchange will enable Nationwide to shift its proposed parking garage to the south and west on vacated portions of 13th and Mulberry Streets. The City will then widen Mulberry and 12th Streets on land to be acquired from Nationwide. The City also intends to widen a portion of 13th Street between Walnut and Locust adjacent to Nationwide's new office building. Funds to widen the streets were included in the Adopted FY2007 – FY2011 CIP.

FISCAL IMPACT:

Amount: Net proceeds to the City of \$40,318 per the terms of the land exchange.

\$575,000 for the street widening projects.

Funding Source: Adopted CIP FY2007 – FY2011, Street Improvements page 51, 12th 13th and Mulberry Street Widening

ADDITIONAL INFORMATION:

The concept of a land exchange to facilitate these projects was contemplated early in discussions with Nationwide. Now that preliminary engineering work is nearly complete on the parking garage, the two parties have identified the exact scope of land to be exchanged and the proper legal descriptions have been prepared. Also, much time has been spent to identify and reserve utility easements in 13th and Mulberry where applicable.

Closing is anticipated to occur no later than July 1, 2007.
