AGENDA HEADING:

Approval of Documents for a Des Moines Action Loan Fund Loan for \$135,000 to ZEN Restaurants, LLC.

SYNOPSIS:

Recommend approval of documents. On May 7, 2007, by Roll Call No. 07-878, City Council approved a \$135,000 Des Moines Action Loan Fund (DMALF) Loan to ZEN Restaurants, LLC. The current action approves documents related to the City loan. Zen Restaurants, LLC is owned and operated by Michael R. Hutchison, 400 28th Street, Des Moines, IA 50312 and Jeremy A Morrow, 4114 Lincoln Place Drive, Des Moines, IA 50312.

ADDITIONAL INFORMATION:

ZEN Restaurants, LLC is owned and operated by Michael R. Hutchison and Jeremy A Morrow. Mr. Hutchison and Mr. Morrow own and operate the Star Bar, which is located at 2811 Ingersoll Avenue, Des Moines. Previously, Mr. Morrow established and operated the Bistro Montage and Bistro 43, which he has since sold.

The City loan is to assist in the purchase of furniture, fixtures, and professional fees for two new restaurants. AZALEA, a new steak and seafood restaurant, and ZEN Sushi & Noodle Restaurant are being developed in leased space on the ground level of the Kirkwood Hotel. The City loan will be repaid at four percent interest over the term of the lease and secured by a junior lien on furniture, fixtures, and equipment as well as personal guarantees of the principals.

The Company has leased a total of 10,000 square feet on the ground level of the Kirkwood Hotel; AZALEA will occupy 5,000 s.f. and ZEN Sushi & Noodle Restaurant will occupy 2,500 s.f.; additionally, the company has renovated the former hotel ballroom (approx. 2,500 s.f.) into meeting and reception space. Also, the company is leasing 7,000 s.f. of basement space for storage and operations. The company projects that it will create 50 new full-time positions at an average wage of \$12 per hour.

ZEN Restaurants, LLC originally estimated total project costs of about \$500,000. Due to the extensive renovations encountered, however, actual project costs are now at approximately \$800,000. The company had arranged bank financing in the amount of \$250,000, based on the original cost estimates; estimates now are \$275,000. The Company's principals are requesting City assistance in the financing of furniture, fixtures, and professional fees. The principals will fund the balance of renovations and working capital from personal and business resources.
