### **AGENDA HEADING:**

Hold Hearing on vacation and conveyance of various segments of right-of-way in the vicinity of 3001 Logan Avenue to the State of Iowa for \$13,280.

## **SYNOPSIS:**

Recommend approval for vacation and conveyance of said property to the State of Iowa under the custody and control of The Iowa State Fair, Gary D. Slater, Manager and CEO, P.O. Box 57130, Des Moines, Iowa, 50317-0003, for \$13,280. This action is required prior to making a final determination on the proposed sale by resolution. There is no current or anticipated public need for this property.

#### ADDITIONAL INFORMATION:

On March 10, 2008, by Roll Call No. 08-383, the City Council adopted a recommendation from the City Plan and Zoning Commission to vacate and convey portions of street and alley right-of-way in the vicinity of 3001 Logan Ave.

The property to be conveyed consists of approximately 56,962 square feet. The buyer will incorporate the rights-of-way into the Iowa State Fairgrounds.

The State of Iowa has submitted an offer of \$13,280 to purchase the above referenced property, which is equal to the estimated Fair Market Value.
