AGENDA HEADING:

Resolution accepting grant from Polk County to be used for the realignment of High Street

SYNOPSIS:

Recommend approval of the resolution to accept a grant from Polk County to be used for the realignment of High Street for Wellmark's new corporate headquarters.

FISCAL IMPACT:

Amount: \$2,000,000 grant

<u>Funding Source:</u> Grant monies will be applied to offset a portion of the \$5,914,500 High Street Realignment as approved in the FY2008-2009 Capital Improvement Program, CP038, ENG990000, STR204, Street Improvements Page 18.

ADDITIONAL INFORMATION:

On April 21, 2008, by Roll Call No. 08-715, the City Council approved an Urban Renewal Development Agreement with Wellmark, Inc. for the redevelopment of the three block area bounded by Grand Avenue, relocated High Street and 11th and 14th Streets, for use as Wellmark's new corporate headquarters.

The planned relocation of High Street between 10th and 14th Streets must be completed to create the parcels needed by Wellmark for the new office building and garage/multi-use building.

The Polk County Board of Supervisors has agreed to assist the City in the retention of Wellmark's home office facilities and the associated employment opportunities by making a grant of \$2 million to the City for the relocation of High Street, with such grant to be distributed in two installments of \$1 million on July 15, 2008, and July 15, 2009. These installments correspond with the project's phasing.

The Letter of Agreement prepared by Polk County simply specifies the terms of the grant installments and requires that the City forward Wellmark's annual employment certifications to Polk County.

Motion Carried 7-0.
