AGENDA HEADING:

Approving Reduction in Surety Bond Amount for Airport Crossroads

SYNOPSIS:

Reduction of the required surety from \$74,757 for a 10 foot wide recreational trail to \$18,689 because of partial completion of the required infrastructure in the plat area.

ADDITIONAL INFORMATION:

The City Council on September 12, 2005 approved the original bond for infrastructure improvements in the amount of \$74,757. The developer, Fleur Properties, LC, Mike Barnes, Principal, 615 Park Street, Suite 300, Des Moines, IA 50309 has requested a reduction in the required surety since much of the required improvements have been made. The Engineering Department has confirmed that much of the required work has been completed, but the amount of work remaining will still require a surety bond in the amount of \$18,689 to ensure that the remaining improvements will be in place when the development in the plat is completed.
