AGENDA HEADING:

Approval of the Supportive Housing Program (SHP), Renewal Grant Agreement with the United States Department of Housing and Urban Development (HUD).

SYNOPSIS:

Recommend Council approval of Supportive Housing Program (SHP) Renewal Grant Agreement by and between the Department of Housing and Urban Development (HUD) and the City of Des Moines for supplemental funding of local homeless programs to address service gaps. The renewal grant agreement provides for a one-year continuation of the Buchanan Transitional Living Center.

ADDITIONAL INFORMATION:

On behalf of the City, the Housing Services Department submitted an application to HUD for SHP funding to provide supplemental funding for local homeless programs to address service gaps in Des Moines and Polk County. HUD has forwarded a SHP renewal grant agreement totaling \$99,390, which requires Council approval. As the applicant, the City is responsible for the overall management and administration of the grant, including draw-downs, fund distribution and reporting to HUD. The aforementioned renewal grant agreement is for a term of one year.

The project sponsor and the activities they will perform are as follows:

Iowa Homeless Youth Centers – Buchanan Transitional Living Center. This is a one-year renewal to provide transitional housing and support services for up to 8 youth. Clients are required to work and/or attend school. The agency currently estimates \$28,571 of local leverage. Last year the project served 31 youth with 23 exiting the program and 15 (48%) exiting to permanent housing.
