Approval of Conveyance of 1237/1239 Highview Dr., to R.B. Long Investment Group LLC

#### SYNOPSIS:

Recommend Council approval to sell Des Moines Municipal Housing Agency disposition property to R.B. Long Investment Group LLC

## FISCAL IMPACT:

<u>Amount</u>: \$88,100

<u>Funding Source</u>: 2008-2009 Operating Budget, Page 174, Housing Services Department Disposed Homes, HSG021500.

The proceeds from the sale will be used accordingly:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

## **ADDITIONAL INFORMATION:**

The Housing Services Department received approval for its application to dispose of 394 Public Housing units at Fair Market Value, via a public bid on August 19, 2003. Where there is a commensurate public benefit, according to federal regulations, sales can be negotiated with a specific buyer.

This property was offered for sale pursuant to the public bid procedures approved by the Municipal Housing Governing Board on October 6, 2003 by Roll Call 03-2267. The purchaser has not been the title holder or owner of an interest in real estate in the City of Des Moines which the Housing Advisory Board recommended for prosecution for rental code violations of Chapter 26 of the Des Moines Municipal Code, as a "Habitual Violator" or declared a "Public Nuisance" by resolution of the City Council.
