## **ADDITIONAL INFORMATION:**

Fighting for a Better World (FBW) is a division of DH Global, Boxing Promotions. The organization's mission statement is as follows: Fighting for a Better World is committed to enhancing human dignity and quality of life, seeking out humanitarian causes and ways to affect positive change in peoples' lives and communities across the country and worldwide. Fighting for a Better World donates funds during each World Xtreme Boxing Challenge event to the spotlighted charity or cause and seeks the support of the community, sponsors and advertisers via monetary contributions.

Fighting for a Better World's goal is to "assist individuals, communities and aide organizations, in furthering our vision for improved well-being and living standards worldwide, while respecting religions and cultures. Through extensive research spanning across the country and world, FBW identifies causes and needs that reflect our mission and supports these through a monetary donation. FBW encourages the support of community businesses in helping by soliciting contributory funds."

The Community Services Division operates as the Community Action Agency for the City of Des Moines. It is charged with providing services to the City's low-income families and trying to address and eliminate causes of poverty. The City became a public Community Action Agency (CAA) in 1977.
