AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes as follows:

- A. Parking restriction on north side of School Street from 8th Street to 12th Street due to I-235 reconstruction.
- B. Parking restriction on east side of SE 21st Street south of Maury Street to allow maneuverability at loading dock at ABC Metals.

SYNOPSIS:

Recommend approval of the Traffic and Transportation Division staff recommendations, including first reading of the Ordinance regarding the traffic regulation changes.

FISCAL IMPACT:

Amount: Minor costs.

<u>Funding Source</u>: 2008-2009 Operating Budget, Page 131, Engineering Department Traffic & Transportation—Sign Installation and Maintenance, ENG100413.

ADDITIONAL INFORMATION:

A. As part of the reconstruction of I-235, the entrance ramps from 12th Street to eastbound and westbound I-235 were removed and relocated to the Keo interchange. School Street east of 12th Street was reconstructed, and now serves as a residential street. Parking is currently allowed on both sides of the street, and the street width does not accommodate parking on both sides. It is recommended to remove a short parking restriction on the south side, to allow parking along the entire south side, and prohibit parking on the north side. The following ordinance changes are necessary to implement these parking changes.

Sec. 114-3624. School Street—Second Avenue to Fortieth Place.

School Street, on the north side, from Eighth Street to Twelfth Street, no parking any time.

School Street, on the south side, from Twelfth Street to a point 405 feet east thereof, no parking any time.

B. The manager at ABC Metals has requested a parking restriction on SE 21st Street to prevent cars from blocking access to their loading dock. Currently, there are no parking restrictions on SE 21st Street south of Maury. It is recommended that parking be prohibited on the east side of the street to allow trucks to maneuver to and from this loading dock. The following ordinance changes are necessary to implement this parking change.

Sec. 114-2804.5 Southeast Twenty-first Street—Maury Street to Dead End South of Maury Street.

Southeast Twenty-first Street, on the east side, from Maury Street to a point 525 feet south thereof, no parking any time.
