AGENDA HEADING:

Hearing on 2008 Expanded Street Resurfacing Program - Contract 3: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, James Gauger, President, \$629,803.

SYNOPSIS:

This is a public hearing to allow for public input on the 2008 Expanded Street Resurfacing Program - Contract 3 and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. This project provides for partial and full depth patching, surface milling, and hot mix asphalt (HMA) overlay of arterial and residential streets citywide. The project addresses citizen concerns regarding the condition of city streets by preserving deteriorating infrastructure.

FISCAL IMPACT:

Amount: \$629,803 Construction Contract (\$632,400 City Engineer's Estimate)

<u>Funding Source</u>: 2008-2009 CIP, Page Street-42, Special City-wide Street Improvements, STR217, (Gaming Monies from the agreement with Polk County and The Racing Association of Central Iowa).

ADDITIONAL INFORMATION:

On August 11, 2008, under Roll Call No. 08-1395, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the 2008 Expanded Street Resurfacing Program - Contract 3. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the 2008 Expanded Street Resurfacing Program - Contract 3, 06-2008-019. The improvement includes scarification of existing asphalt streets, furnish and place hot mix asphalt, and other incidental items; in accordance with the contract documents, including Plans File Nos. 491-104/109, at the following locations:

- •56th Street College Avenue to Franklin Avenue
- •50th Street Hickman Road to Urbandale Avenue
- •56th Street Madison Avenue to Aurora Avenue
- •Sheridan Avenue 44th Street to Beaver Avenue

- •Washington Avenue 16th Street to ML King Jr. Pkwy.
- •Clinton Avenue 6th Street to 12th Street
- •Royer Street E 14th Street to Dead End East of E 14th Street
- •Pleasantview Drive SE 14th Street to SE 17th Street
- •SE 8th Street Park Avenue to Indianola Road.

Sealed bids for said improvement were submitted by the following bidders:

OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, Des Moines, IA Grimes Asphalt & Paving Corp., Grimes, IA

The bids were received and opened at a public meeting presided over by the City Engineer in the City Council Chambers, 2nd Floor, City Hall, 400 Robert D Ray Drive, Des Moines, Iowa at 11:00 a.m. on August 26, 2008.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, James Gauger, President, 5550 NE 22nd Street, P.O. Box 3365, Des Moines, IA, 50316-0365 in the amount of \$629,803, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
