#### **AGENDA HEADING:**

Hearing on application from Efrain Mayorga of 1301 S.E. Watrous, d/b/a Aztec Motors, for relief from the moratorium on establishment or expansion of vehicle display lots as applied to a vehicle display lot at 908 S.E. 14th Street.

## **SYNOPSIS:**

Efrain Mayorga (Mayorga & Mayorga Partners) is the owner of Aztec Motors at 908 S.E. 14<sup>th</sup> Street. Mayorga Partners purchased the adjoining 0.208 acre property at 824 S.E. 14<sup>th</sup> Street on June 30, 2008 and would like to expand the existing 0.659 acre vehicle display lot. The expansion would result in the removal of an existing commercial building at 824 S.E. 14<sup>th</sup> Street that is assessed at \$18,700. The expansion would increase the total business frontage along S.E 14<sup>th</sup> Street from 363.85 feet to 419.85 feet.

If relief to the moratorium is granted, the applicant will be required to submit a site plan that complies with the existing site plan standards for vehicle display lots for review by the Plan and Zoning Commission. However, if the City Council ultimately decides to amend the site plan standards for vehicle display lots in the future, it is possible that a legal non-conforming use will be re-established on the subject property.

# **FISCAL IMPACT:**

Amount: Annual property tax loss of approximately \$310 based upon the existing building's

assessed value of \$18,700.

Funding Source: General Fund Property Tax Revenue.

# **ADDITIONAL INFORMATION:**

On August 25, 2008 the City Council approved an extension of the temporary moratorium until November 11, 2008, which provides in relevant part as follows:

"1. No vehicle display lot shall be created or expanded and no site plan shall be approved for the creation or expansion of a vehicle display lot, at any location within the City of Des Moines that is zoned to the "C-2" General Retail and Highway Oriented Commercial District. The City Staff shall not issue any permit for any development which is prohibited by this section. This moratorium shall not apply to the completion and use of a vehicle display lot or

expansion of a vehicle display lot which has been commenced under a valid permit and is diligently pursued to completion."

The existing site plan for Aztec Motors was approved by the Plan and Zoning Commission April 5, 2007 subject to conditions. Aztec Motors is nearing completion of all improvements in accordance with the approved site plan and the full assessed value of the property increased from \$77,700 in 2007 to \$140,800 in 2008 due to construction of a new building on the property.
