## AGENDA HEADING:

Approving application for a Community Response Grant from the Greater Des Moines Community Foundation by the Des Moines Police Department for a graffiti camera.

## SYNOPSIS:

Recommend approval of a grant application to the Greater Des Moines Community Foundation for a graffiti camera that will be shared by the neighborhoods that make up the Coalition of South Side Neighborhood Associations (CSSNA).

## FISCAL IMPACT:

Amount: \$3,995 grant request. \$2,000 in donations committed from the CSSNA.

Funding Source: Grant proceeds and donations received for the graffiti camera will be posted to SP809, POL980400, Police Training and Equipment, FY09 Operating Budget, Page 284.

## ADDITIONAL INFORMATION:

A request for approval to submit a Letter of Intent to the Greater Des Moines Community Foundation was approved by the City Council on September 8, 2008. The Foundation notified the Police Department on September 23, 2008 of our advancement in the 2008 Fall Community Response Grant Cycle. The Coalition of South Side Neighborhood Associations has raised \$2,000 in donations to be directed towards the cost of the graffiti camera. The grant request has been reduced to \$3,995 to reflect the donations committed toward the \$5,995 required for the graffiti camera.

The grant proceeds will be utilized to fund a graffiti camera to be shared by the nine neighborhood associations that make up the CSSNA which include the following neighborhoods:

South Park
