ADDITIONAL INFORMATION:

On June 4, 2007, by Roll Call No. 07-1046, City Council approved a professional services agreement with Howard R. Green Company to provide construction administration services for the Ingersoll Streetscape - 28th to 31st Street Project. Since the approval of this agreement, additional unforeseen events have occurred that require additional work by the consultant. Additional work includes coordination efforts with Restoration Ingersoll, property owners, private electrical contractors, and MidAmerican Energy to revise electrical services along the north side of the project, installation of conduits for festival lighting at the request of Restoration Ingersoll, coordination with the Stickel Development adjacent to the project, investigation of unmapped sewers, roof drains, water services, and damaged sewers, coordination with MidAmerican Energy on unexpected gas main relocations, and additional time on the project due to a longer than anticipated construction period. Staff recommends approving the Professional Services Supplemental Agreement No. 1 with Howard R. Green Company.
