AGENDA HEADING:

Approval of Iowa Department of Commerce, Alcohol Beverage Division 28E Agreement, funding to support tobacco compliance checks of retailers for sale to minors.

SYNOPSIS:

The Iowa Department of Commerce, Alcohol Beverage Division, has funding available to support a program to conduct two (2) compliance checks of cigarette permit holders for compliance with prohibition on the sale of tobacco to minors. The Vice and Narcotics Control Section of the Police Department would conduct these checks on an overtime basis for reimbursement from the Iowa Department of Commerce.

FISCAL IMPACT:

Amount: None

It is estimated compliance checking at approximately 300 establishments for a total cost of approximately \$20,000. The costs for the program will be reimbursed.

Funding Source: FY2009 Operating Budget, Page 260, Vice and Narcotics Control, GE001, POL010700. Reimbursed by the Iowa Department of Commerce, Alcohol Beverage Division.

ADDITIONAL INFORMATION:

The Iowa Department of Commerce has received funds from the tobacco settlement to conduct checks on tobacco retailers for compliance with prohibitions on the sale of tobacco to minors.

The Vice and Narcotics Control Section of the Police Department will perform the work on an overtime basis. The City has approximately 300 cigarette license permit holders. Random and unannounced compliance checks will be made on these permit holders.

The City will be reimbursed \$50 for each compliance check. We estimate the cost will be approximately \$20,000 which is completely reimbursable. This is a continuation of previous efforts within the same program.
