AGENDA HEADING:

Approval of one hundred forty-six (146) tax abatement applications for improvements to property completed in 2008.

SYNOPSIS:

Recommend Council approval of 146 tax abatement applications with an estimated value by the applicants of \$27,520,246. There were 71 applications for the construction of new single family homes, apartments, and new businesses with an estimated value of \$21,386,754 and 75 applications for improvements to existing structures with an estimated value of \$6,133,492.

FISCAL IMPACT:

<u>Amount:</u> Tax abatement upon property with a claimed value of \$27,520,246.

<u>Funding Source</u>: Taxes will only be generated from the land value while abatement is in effect. Taxes on the \$27,520,246 improvement value will be forth coming when the improvement value comes on the tax rolls after abatement ends.

ADDITIONAL INFORMATION:

A total of 146 tax abatement applications are being submitted at this time with an estimated value by the applicants of \$27,520,246. There were 71 applications for the construction of new single-family homes, apartments, and new businesses with an estimated value of \$21,386,754 and 75 applications for improvements to existing structures with an estimated value of \$6,133,492.

A total of 34 applicants chose **Schedule 1** with an estimated value of \$587,178. **Schedule 1** is for qualified residential property. Applicants receive an exemption from the taxation on the actual value of improvements not to exceed \$20,000. The exemption period is ten years and the exemption amount is 115% of the actual value added by improvements.

A total of 2 applicants chose **Schedule 2** with an estimated value of \$343,000. **Schedule 2** is for all qualified real estate and will receive a partial exemption for ten years. The exemption schedule is a declining schedule and starts with the first year at 80% and ends in year ten at 20%.

A total of 3 applicants chose **Schedule 3** with an estimated value of \$886,407. All qualified real estate is eligible to receive an exemption from taxation on the actual value added by the improvements for three years. This schedule also applies to commercial and industrial real estate is eligible to receive an

exemption from taxation on the actual value added by the improvements for three years. This schedule also applies to commercial and industrial property in specific areas.

A total of 31 applicants chose **Schedule 4A** with an estimated value of \$13,986,540. **Schedule 4A** is for qualified real estate in specific areas generally located downtown and near the downtown area. The exemption period is ten years and the exemption amount is 100% of the actual value added by improvements. Qualified real estate assessed as residential or assessed as commercial consisting of three or more living quarters with at least 75% of the space used residentially is eligible to receive an exemption from taxation and the actual value added by the improvements.

A total of 76 applicants chose **Schedule 4B** with an estimated value of \$11,717,121. **Schedule 4B** is for qualified real estate for the remainder of the City for a period of five years. Qualified real estate assessed as residential or commercial and consisting of three or more living quarters with at least 75% of the space used residentially is eligible to receive an exemption from taxation on the actual value added by improvements. The exemption amount is 100% of the actual value added by the improvements.

In order to receive tax abatement on a property, the applicant must increase the value of residential property at least 5% for residential or 15% for commercial and industrial property.
