## **AGENDA HEADING:**

Approving permanent closure of a portion of West River Drive at 2<sup>nd</sup> Avenue.

# **SYNOPSIS:**

Recommend approval of the permanent closure of the southern 400 feet of West River Drive at 2<sup>nd</sup> Avenue to allow the construction of the Principal Riverwalk.

#### **ADDITIONAL INFORMATION:**

The Corps of Engineers has Greenbelt funding available for Principal Riverwalk construction. The Corps of Engineers is currently putting together a contract bid package for Spring 2009. Construction of the permanent approaches and trail connections to the Center Street Pedestrian Bridge is expected to begin by next summer. The Principal Riverwalk plans include the permanent closure of West River Drive and construction of a parking area and cul-de-sac that will serve people visiting the Riverwalk and Iowa Events Center. Construction of the permanent approaches and trail connection on the west end of the Center Street Pedestrian Bridge will require closure of the southern 400 feet of West River Drive just north of 2<sup>nd</sup> Avenue. West River Drive will remain open from the north to provide access, but will no longer be a through street extending from Illinois Street on the north to 2<sup>nd</sup> Avenue on the south. The Corps of Engineers construction project will include the permanent trail connections to the Center Street Pedestrian Bridge and permanent removal of the southern-most portion of West River Drive. In order for the construction to proceed, the permanent closure of West River Drive must be resolved.

Following Council's action on March 12, 2007, by Roll Call 07-489, to refer the permanent closure of a portion of West River Drive to the City Manager for review, input was sought from the following stakeholders.

- Central Place Business Association Correspondence was sent to representatives of the Central Place Business Association soliciting their concerns regarding the permanent closure of the street. No response was received.
- Park and Recreation Board The permanent closure of West River Drive was presented to the Park and Recreation Board for consideration on January 22, 2008. The Park and Recreation Board recommended the permanent closure of the southern-most portion of West River Drive.
- Des Moines Riverfront Development Authority (RDA) The closure of West River Drive was most recently discussed at the January 8, 2008 RDA meeting. The Board of Directors of the

RDA provided a letter supporting the proposed closure of West River Drive.

The southern-most portion of West River Drive has been closed to traffic since August 13, 2007 as it is within the contractor's work zone for the Center Street Pedestrian Bridge. Since that time, there have been no noted affects to the traveling public.
