## **AGENDA HEADING:**

Receive and File the Financial Statements of the Des Moines International Airport (City of Des Moines Aviation Department) for the year ended June 30, 2008, including Independent Auditor's Reports as prepared by McGladrey & Pullen, LLP.

#### **SYNOPSIS:**

Recommend that City Council receive and file the Independently Audited Financial Statements of the Des Moines International Airport for Fiscal Year 2007.

#### **FISCAL IMPACT:**

Amount: \$13,734 - paid to McGladrey & Pullen LLP, Moline, IL, for auditing services.

<u>Funding Source</u>: Fiscal Year 2009 Operating Budget, Airport Operations Fund, Administration, EN002, AIR010100.

# **ADDITIONAL INFORMATION:**

Ordinance 12.040 established a Des Moines International Airport Board and among the responsibilities assigned to the Board was to "ensure that all Airport revenues collected by or under Board authority are credited to the Airport Enterprise Fund, and that all expenditures from said fund are done in accordance with applicable state and federal laws and regulations." Because the Aviation Department functions as an Enterprise Fund of the City, the City Finance Department has historically managed all audit requirements related to Airport receipts and disbursements.

Based on a past recommendation of the Airport Board, the Aviation Department automatically engages the same independent accounting firm as used by the City. Currently, the City issues a Request for Proposals (RFP) for auditing services every three years as part of its normal procedures. The City's most recent RFP covers fiscal years ending June 30, 2004, 2005, and 2006, with the option of extending an additional two years by mutual agreement. This RFP included the completion of the Airport's required audit reports. The successful bidder on this RFP was McGladrey and Pullen, LLP (McGladrey) and the final option year on the contract was utilized to cover the fiscal year ended June 30, 2008.

McGladrey recently completed the Airport audit for the fiscal year ended June 30, 2008, and issued an unqualified audit report on the Airport's financial statements, its compliance and control over financial reporting procedures, and its compliance with requirements applicable to the Passenger Facility Charge Program. Copies of each audit report and financial statements have previously been presented to the Airport Board for review and a complete copy is now submitted to the Council. The financial statements as presented also include comparative information from the fiscal year ended June 30, 2007.

It should also be noted that the Airport's financial information and Federal grant information is reported as part of the City's Comprehensive Annual Financial Report (CAFR). The financial statements are available for public viewing at the Aviation Department's administrative offices as well as via the Airport's website at <a href="http://www.dsmairport.com/AboutUs/Annual\_Report.htm">http://www.dsmairport.com/AboutUs/Annual\_Report.htm</a>.

As noted within the Auditor's Report, there were no findings or questioned costs and the Airport received an unqualified opinion, which is the highest level of audit opinion available.
