ADDITIONAL INFORMATION:

The City of Des Moines Municipal Housing Agency (DMMHA) is applying for additional funding from HUD for non-elderly disabled designated housing choice vouchers.

As a requirement for submitting a grant application for the designated funding, housing agencies must develop and maintain a Code of Conduct to reflect core values in their Administrative Plan for the Section 8 Housing Assistance Payments Program. (Exhibit 1 attached to the roll call) The Code of Conduct includes HUD regulation, Policy 1.12 of the City of Des Moines Administrative Manual, and the City of Des Moines Municipal Housing Agency's disclosure policy.

In addition, the Section 8 Housing Assistance Payments Program Administrative Plan must include a Non-Elderly Disabled Persons Fair Housing Addendum.(Exhibit 2 attached to the roll call) The Addendum will add language to the Equal Opportunity Housing Plan attachment to the Administrative Plan. The Fair Housing for Non-Elderly Disabled Persons Addendum outlines steps DMMHA will take to affirmatively further fair housing for non-elderly disabled persons assisted under the grant.
