SYNOPSIS:

Recommend approval to sell Des Moines Municipal Housing Agency disposition property located at 1234 and 1236 McKinley to Jocelyn M. Scholer.

The proceeds from the sale will be used accordingly:

- Affordable Housing Endowment Fund (75%)
- Physical Improvements to existing Manors (25%)

ADDITIONAL INFORMATION:

The Housing Services Department received approval for its application to dispose of 394 Public Housing units at Fair Market Value, via a public bid on August 19, 2003. Where there is a commensurate public benefit, according to federal regulations, sales can be negotiated with a specific buyer.

This property was offered for sale pursuant to the public bid procedures approved by the Municipal Housing Governing Board on October 6, 2003 by Roll Call 03-2267. The purchaser has not been the title holder or owner of a real estate interest in the City of Des Moines that the Housing Advisory Board has recommended for prosecution as a "Habitual Violator" pursuant to Municipal Code Chapter 26 (rental code violations) or been declared a "Public Nuisance" by resolution of the City Council.
