AGENDA HEADING:

Approval of 2010 Governor’s Traffic Safety Bureau (GTSB) Section 402 Grant Application

SYNOPSIS:

Recommend approval of the 2010 Governor’s Traffic Safety Bureau Section 402 Grant Application directed at pedestrian safety, occupant protection enforcement, speeding, drug and alcohol impaired drivers and other traffic safety related activities. This grant is a traffic enforcement grant that the Des Moines Police Department has received since 1988.

FISCAL IMPACT:

Amount: \$166,300.32

Funding Source: National Highway Traffic Safety Administration (NHTSA), Public Law 105-178, Section 402. 2008-2009 Operating Budget, Page 284, Special Revenue Funds, SP751. An organizational Code will be assigned once award notice has been received.

ADDITIONAL INFORMATION:

The grant application provides \$166,300.32 for the Police Department to fund the following:

- \$160,090 for officer overtime to conduct 3500 hours of traffic enforcement directed at alcohol/drug impaired drivers and other traffic violations.
- \$2,195.52 of officer overtime to conduct 48 hours of child safety seat check points.
- \$914.80 of officer overtime to conduct 20 hours of bicycle safety awareness for school children.
- \$1,500 for 100 bicycle helmets.
- \$2,000 for GTSB approved travel and training.

The grant period is from October 01, 2009 through September 30, 2010. There is no match for this grant.
