ADDITIONAL INFORMATION:

Supplemental Agreement No. 4 includes the construction phase services needed for the Southeast Connector Paving – SE 4th street to SE 9th Street. Work includes construction administration, on-site observation, and materials testing and plant monitoring. The work will include observation and administration required to satisfy City of Des Moines and Iowa Department of Transportation (DOT) requirements.

The Request for Proposal (RFP) and selection process included construction phase services as part of the project. However, until design is completed and construction is planned, the scope of work to perform construction phase services on a project cannot be finalized. The need for future supplemental agreements for construction phase services on each construction project were noted when the original contract was approved.
