# **AGENDA HEADING:**

Resolution approving issuance of a Certificate of Completion for Nationwide Mutual Insurance Company's new parking facility located at 1206 Mulberry Street and Final Certificate of Completion for the entire urban renewal development project.

# SYNOPSIS:

On May 8, 2006, by Roll Call No. 06-950, the City Council approved an Urban Renewal Development Agreement with Nationwide Mutual Insurance Company ("Nationwide") whereby Nationwide agreed to construct the following Improvements in accordance with the Development Agreement and an approved Preliminary Development Plan:

- 1. An addition onto the existing office building on Parcel "A" at 1100 Locust Street containing at least 280,000 square feet of gross floor area (the "Office Expansion").
- 2. A new office building on Parcel "C" at 1200 Locust Street containing an estimated 360,000 square feet of gross floor area (the "New Office Building").
- 3. A new garage on Parcel "E" at 1206 Mulberry Street containing approximately 1,500 parking spaces.

On February 25, 2008, by Roll Call No. 08-313 the City Council approved the issuance of a Certificate of Completion finding that the Office Expansion has been completed in substantial compliance with the approved Preliminary Development Plan.

On December 8, 2008, by Roll Call No. 08-2127 the City Council approved the issuance of a Certificate of Completion finding that the Office Expansion has been completed in substantial compliance with the approved Preliminary Development Plan.

Pursuant to the Development Agreement, Nationwide has now completed the parking facility, in substantial compliance with the approved Preliminary Development Plan, and has requested the City issue a Certificate of Completion as evidence of satisfaction of Nationwide's construction obligations. The parking garage is the final component to be completed and Nationwide has also requested the City issue a final Certificate of Completion recognizing completion of the entire project. City staff recommends approval of the Certificate of Completion.

## FISCAL IMPACT:

<u>Amount:</u> No new funds are committed pursuant to this action. Issuance of the Certificate of Completion will cause payment of the previously approved economic development incentives. Upon request by the City Manager or his designee, the Finance Department is hereby authorized to pay and release to

Nationwide twenty equal annual installments of \$1,045,000 pursuant to Section 503(C) of the Development Agreement. Payments commence November 1, 2011.
