ADDITIONAL INFORMATION:

T.M. Franklin Cownie (R-3) Mayor, to Washington, D.C., from May 18 - 21, 2009, (\$2,287), to participate in the Local Climate Leadership Summit. The Summit will cover how new federal economic recovery resources can help communities create jobs, improve energy efficiency and reduce greenhouse gas emissions.

Mark Gregory (R-0) Project Specialist, to Omaha, NE, from May 3 - 6, 2009, (\$1,753), to attend the Housing Choice Voucher Housing Quality Standards course sponsored by Nan McKay & Associates. The 3 day class provides information on general room standards, kitchens, bathrooms, electricity, plumbing and security, including lead-based paint regulations.

Vicky Long Hill (R-0) Assistant City Attorney, to San Diego, CA, from July 31 – August 9, 2009, (\$1,600), to attend the National Bar Association's 83rd Annual Convention & Exhibits.

Mike Matthes (R-1) Assistant City Manager/CIO, to Dallas, TX, from May 17 – 21, 2009, (\$2,000), to attend the 33rd Annual International Association of Chiefs of Police (IACP) Law Enforcement Information Management Training Conference and Exposition. The Conference brings together law

enforcement practitioners to improve and facilitate the exchange of information and system interoperability within and across jurisdictional boundaries.

Tom Vlassis (R-3) City Council Member, to Savannah, GA, from May 6 - 10, 2009, (\$1,053), to attend, as a representative of the City of Des Moines, the National League of Cities Community and Economic Development Steering Committee meeting.

The amended budget for travel in Fiscal Year 2009 (FY09) is \$367,874 reflecting a 29.3% reduction from the original adopted budget of \$520,011. The amended budget for training in FY09 is \$311,045 reflecting a 1% reduction from the original adopted budget of \$313,997. The amount expended for travel and training in FY09 as of April 14, 2009 is \$333,010.
