Public Hearing on Twenty-Second Amendment to the Restated Urban Revitalization Plan for the City-Wide Urban Revitalization Area.


SYNOPSIS:

Recommend Council approval of the proposed 22nd Amendment to allow tax abatement for the construction of office buildings of at least 15,000 gross square feet in the Downtown East New Office Construction tax abatement sub-area, shown on this map.

ADDITIONAL INFORMATION:

A new medical office building for primary care physicians and an 'urgent care' facility is proposed to be built directly east of the existing Capitol Medical Offices at 1300 Des Moines Street by LADCO Development, Inc. The developer has requested tax abatement in order to proceed with the project. The proposed new construction totals about 17,000 square feet, which does not qualify for tax abatement under the current standard, which requires a minimum of 25,000 square feet of new construction.
