# AGENDA HEADING:

Hearing on application of Imperial Properties, Inc., Bill Moyer, Agent, for relief from the temporary moratorium on the creation or expansion of vehicle display lots at 4141 E. 14th Street.

## SYNOPSIS:

The applicant has been cited for illegally expanding a vehicle display lot located at 4131 E. 14<sup>th</sup> Street onto adjoining property at 4141 E. 14<sup>th</sup> Street. The applicant proposes to bring 4141 E. 14<sup>th</sup> Street into compliance with the site plan regulations for vehicle display lots to resolve the zoning violation issue. The request constitutes the expansion of the existing vehicle display lot.

The temporary moratorium is set to expire on June 9, 2009, unless it is extended by the City Council. If the Council does not elect to extend the moratorium, then no action on this item is necessary. If the moratorium is extended and a date for public hearing is set regarding the proposed Vehicle Display Lot Overlay District, then staff recommends denial of the applicant's request for relief to the moratorium.

### **ADDITIONAL INFORMATION:**

On March 9, 2009, the City Council extended a temporary moratorium effective until June 9, 2009, which provides in relevant part, as follows:

"1. No vehicle display lot shall be created or expanded and no site plan shall be approved for the creation or expansion of a vehicle display lot, at any location within the City of Des Moines that is zoned to the "C-2" General Retail and Highway Oriented Commercial District. The City Staff shall not issue any permit for any development which is prohibited by this section. This moratorium shall not apply to the completion and use of a vehicle display lot, or expansion of a vehicle display lot, which has been commenced under a valid permit and is diligently pursued to completion."

On June 8, 2009, the City Council will consider whether to set a date of public hearing regarding the proposed Vehicle Display Lot Overlay District and whether or not to extend the temporary moratorium beyond June 9, 2009.
