### **AGENDA HEADING:**

Authorizing Compromise of Judgment with Donna L. Barnes.

# **SYNOPSIS:**

Recommend approval for Donna L. Barnes, the owner of the property at 2207 E. 14<sup>th</sup> Street, who is attempting to settle a judgment by payment of a reduced lump sum, has asked the City to accept and take, as a compromise, \$6,000 in order to facilitate settlement.

## **FISCAL IMPACT:**

Amount: Amount owed to the City \$12,064.77; recommended settlement \$6,000.

### **ADDITIONAL INFORMATION:**

2207 E. 14<sup>th</sup> Street was a public nuisance property, demolished by the City. The total bill for demolition costs, court costs and Neighborhood Inspection fees was \$14,437.34. The City's collection agents, Abendroth & Russell started collection efforts in April of 2008 and by garnishments of approximately \$100.00 per month have received \$2,372.57 leaving a balance due of \$12,064.77. After reviewing the facts and circumstances and upon the recommendation of the City's collection agents, Abendroth & Russell, the Legal Department is of the opinion that liability and settlement of the judgment for \$6,000.00 is in the best interest of the City of Des Moines.
