AGENDA HEADING:

Public Hearing on the proposition to authorize supplement no. D-2 to the governmental lease-purchase master agreement between the City of Des Moines and De Lage Landen Public Finance LLC, Frank Hill, Vice President of Sales, 2600 Grand Blvd. Ste. 380, Kansas City, MO 64108, in the principal amount of, not to exceed \$1,116,017, for the purpose of acquiring certain items of equipment as described herein and providing for publication of notice thereof.
