#### ADDITIONAL INFORMATION:

**Vidal Spaine (R-0) Sister City Commissioner,** to Stavropol, Russia, from June 28 – July 5, 2009 (\$2,125), representing the City of Des Moines in discussions with government leaders from Stavropol to further relations through exchanges related to government operations, education systems, tourism, the arts, and culture.

**Rex Sparks (R-0) Identification Technician,** to Norman, OK, from July 12 – July 18, 2009 (\$1,832), to attend a Shooting Incident Reconstruction Course sponsored by Bevel, Gardner & Associates. Through a series of classes, laboratories and practical exercises, students will learn to interpret the dynamic relationship between the scene, evidence, and victim(s) injuries.

**Michael Towey (R-0) Human Relations Specialist**, to Washington, D.C., from July 12 – July 17, 2009 (\$2,189), to attend the mandatory "National Fair Housing Training Academy."

The amended budget for travel in Fiscal Year (FY) 2009 is \$367,874, reflecting a 29.3% reduction from the original adopted budget of \$520,011. The amended budget for training in FY09 is \$311,045, reflecting a 1% reduction from the original adopted budget of \$313,997. The amount expended for travel and training in FY09 as of June 15, 2009 is \$468,178.
