### **AGENDA HEADING:**

Approval of grant agreements with the U.S. Department of Housing and Urban Development (HUD) for funding of the City's 2009 HUD Consolidated Plan.

## **SYNOPSIS:**

Recommend Council approval of grant agreements by and between HUD and the City of Des Moines, whereby the City will receive Community Development Block Grant (CDBG), HOME Investment Partnership Program (HOME) and Emergency Shelter Grant (ESG) funding (grant awards) for the implementation of the 2009 HUD Consolidated Plan for the period of January 1, 2009 to December 31, 2009.

HUD has now forwarded grant agreements for CDBG, HOME, and ESG funding for the City's 2009 HUD Consolidated Plan. The grant agreements require Council approval and the Mayor's signature.
