ADDITIONAL INFORMATION:

Bruce Braun (R-0) Street Maintenance Administrator, to Columbus, OH, from September 12 – 16, 2009, (\$1,788.23), to attend the 2009 American Public Works Association International Public Works Congress and Exposition. The conference is the premier annual event to obtain the latest information on road maintenance issues.

Garry Fuller (R-0) Inspections and Maintenance Supervisor, to High Point, NC, from July 26 – 31, 2009, (\$2,286), to attend a seminar hosted by Nan McKay and Associates. The seminar is designed to teach how to reevaluate the City's housing portfolio and plan strategically, leverage and expand resources through entrepreneurial business development, to master and manage project-based PHAS and asset management criteria and other public housing-related topics.

Diane Goldsbury (R-0) Senior Police Officer, to Seattle, WA, from September 19 – 25, 2009, (\$2,194), to attend the 47th Annual International Women Police Annual Training Conference. The training will include topics of Identity Theft, Winning Courtroom Confrontations, Career and Tactical Survival for Women, Death Investigations and a case study on the Green River Serial Killer.

Joe A. Gonzalez (R-0) Sergeant, to Anaheim, CA, from November 1 – 5, 2009, (\$1,899), to attend the 20th Annual Problem-Oriented Policing Conference. The conference recognizes excellence and innovation in the use of problem-solving by police, to address public safety.

Eric Nevins (R-0) Communications Supervisor, to Las Vegas, NV, from August 13 – 20, 2009, (\$1,454.55), to attend the 75th Annual Associated Public Safety Officials Conference. The conference will offer seminars and courses in different aspects of public safety communications technology. In addition, 275 exhibitors will be in attendance to display the latest communication technology.
