AGENDA HEADING:

Resolution to close public hearing to correct legal description for Disposition Parcel No. 28A (South of Thompson Avenue to E. Jefferson Avenue on De Wolf Street) in the Guthrie Avenue Business Park Urban Renewal Area and to approve amended disposition related documents for conveyance of said parcel with corrected legal description.

SYNOPSIS:

By Roll Call No. 09-678, dated April 20, 2009, City Council gave final approval to an Urban Renewal Development Agreement with Doll Distributing, Mark Doll, CEO, 815 South Branch, Waukee, Iowa 50263, to redevelop City-owned Disposition Parcel No. 28A in the Guthrie Avenue Business Park, and approved conveyance of said parcel to Doll Distributing. A scrivener’s error occurred in the legal description for the parcel, which has now been corrected and amended in the following documents:

- 1.) Urban Renewal Development Agreement with Doll Distributing
- 2.) Declaration of Covenants
- 3.) Special Warranty Deed

Council is requested to authorize the Mayor to execute the amended disposition documents.

FISCAL IMPACT:

Amount: The developer will purchase Disposition Parcel No. 28A at fair market value for \$74,250.

Funding Sources: Land sale proceeds from Doll Distributing to be re-deposited in the Guthrie Avenue Urban Renewal Area, FY10 Operating Budget, Fund GE001, Org CMO100000, Project URR012, page 47.

ADDITIONAL INFORMATION:

Doll Distributing (formerly Nesbit) has been located at 1901 De Wolf in the Guthrie Avenue Business Park since 1999. The selection of their current site was motivated, in large part, by the direct access to rail. Rail is no longer a means of transporting their products, so the company was left with a critical decision to make regarding their future. The ability to add to their current 135,000 square foot facility and enhance their freight operations has solidified their decision to remain in Guthrie Avenue Business Park and within the City of Des Moines. The total estimated cost of building construction and site preparation is \$1.8 million. The land will be sold for an estimated \$74,250.
