AGENDA HEADING:

Approve Grant Agreement Between the City of Des Moines and the Iowa Department of Transportation in the Amount of \$566,730.00 for Capital Improvements at the Des Moines International Airport.

SYNOPSIS:

The 2009 Iowa Legislature appropriated \$1,500,000.00 to the Commercial Air Service Airport Infrastructure Fund for the fiscal year beginning July 1, 2009, and ending June 30, 2010, for improvements at all eight Commercial Service Airports within the State. Under the current distribution formula, each airport receives an equal share of one half of the total \$1,500,000.00. The remaining forty percent and ten percent of funds are divided based on passenger enplanements and cargo activity, respectively. The passenger enplanement and cargo data to be used will be the most current available from the Federal Aviation Administration (FAA). In this case it is for calendar year 2008. There is no requirement for a local match. This distribution formula is the same as last fiscal year and the Iowa Department of Transportation (IDOT) has stated they will use the FAA enplanement data from calendar year 2008 in order to process applications earlier than in previous years. This will provide the Des Moines International Airport \$566,730.00 for Fiscal 2010.

FISCAL IMPACT:

Amount: Under the FY10 Commercial Service Infrastructure Grant Program the Des Moines International Airport is to receive \$566,730.00.

Funding Source: It is anticipated that these grant funds will be used for all or part of projects listed in the approved work plan. An important note for this year’s grant is that the state legislature will program the Commercial Service Vertical Infrastructure Program from the sale of tobacco securitization bonds. As a result the Airport will not spend any of the FY10 grant until we are notified by the state that programming is available.

ADDITIONAL INFORMATION:

On April 7, 2009, by Resolution No. A09-064, the Board approved the application for the FY 2010 Commercial Service Vertical Infrastructure Program. The Iowa Transportation Commission approved the grant application for Des Moines International Airport with the following projects:

1. Continued Programming of Airfield Vehicle Storage Building
2. Airport Terminal Modifications for EDS Deployment
3. Construct Sand/Chemical Storage Building
4. Self Service Fuel Facility

The Airport has submitted these various projects to allow funding flexibility based on needs as funds are available and more accurate project costs can be determined. The Commercial Service Vertical Infrastructure Fund rules allow airports to fund all or parts of approved projects based on the needs of the individual airport.

On August 4, 2009, by Resolution No. A09-137, the Airport Board recommended the City Council approve the grant agreement between the City and IDOT.
