Formal recognition of the Prospect Park Neighborhood Association according to the Neighborhood Recognition Policy.

## **ADDITIONAL INFORMATION:**

The Des Moines City Council approved the City of Des Moines Neighborhood Recognition Policy on May 24, 1993 by Roll Call No. 93-2026. The intent of this policy is to assist citizens of Des Moines sharing common identity, goals, and concerns to form an organization which will be formally recognized by city government boards, committees and councils and will act as an advisory body when dealing with decisions made by the City and its entities. The policy wishes to recognize the fact that the long term stability of a neighborhood depends on the existence of strong neighborhood based organizations able to demonstrate broad, grassroots participation and the ability to provide leadership and command respect in working with the City and other public and private interests.

In order to implement this policy, Planning Staff developed a strategy that consisted of providing information about the policy and requested information from the neighborhood organizations. Organizations who wish to become recognized must submit the following information: 1) official name of organization, 2) detailed neighborhood boundaries, 3) a list of the organization's representatives with their address and telephone number, 4) the location and time of their membership meetings, and 5) a copy of the organization's bylaws.

The Prospect Park Neighborhood Association has completed an application for recognition. Their neighborhood boundaries include Euclid Ave./30<sup>th</sup> St. between Douglas Ave. and Holcomb Ave. on the west, the Des Moines River from Euclid Ave. to Hickman Rd. on the east, Euclid Ave./Douglas Ave. between Lawnwoods Dr. and the Des Moines River on the north, and Bennett Ave. between 30<sup>th</sup> St. and 27<sup>th</sup> Pl., 27<sup>th</sup> Pl., between Holcomb Ave. and Sheridan Ave., Sheridan Ave. between 27<sup>th</sup> Pl. and Martin Luther King, Jr. Pkwy., Martin Luther King, Jr. Pkwy. between Sheridan Ave. and Hickman Rd.,

Hickman Rd. between Martin Luther King, Jr. Pkwy. and the Des Moines River comprises the southern boundary.

The southern boundary of the Prospect Park Neighborhood matches up with the northern boundary of the Martin-Hickman Neighborhood between 30<sup>th</sup> St. and Martin Luther King, Jr. Pkwy. These two neighborhood groups worked together to ensure that there is no overlap or islands left between them.

At their meeting on August 5, 2009 the Neighborhood Revitalization Board recommended this application for approval. In accordance with the Policy, each recognized neighborhood organization would receive a proclamation from the Mayor and the City Council.
