AGENDA HEADING:

Hearing on McKinley Avenue Resurfacing - Fleur Drive to South Union Street: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, James Gauger, President, \$339,405.16.

SYNOPSIS:

This is a public hearing to allow for public input on the McKinley Avenue Resurfacing - Fleur Drive to South Union Street and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. On April 6, 2009, the City Council approved an Iowa Department of Transportation Agreement for Federal Stimulus project funding under the American Recovery and Reinvestment Act of 2009 for 100% of construction costs to a maximum amount of \$400,000 for McKinley Avenue Resurfacing from Fleur Drive to South Union Street which includes scarification of the existing roadway and resurfacing with hot mix asphalt.

FISCAL IMPACT:

Amount: \$339,405.16 Construction Contract (\$355,000 City Engineer's Estimate)

<u>Funding Source</u>: 2009-2010 CIP, Page Street-32, Rehabilitation and Preservation of Major Roadways, STR222, Being: \$339,405.16 in Federal Stimulus Funds from the American Recovery and Reinvestment Act (ARRA) of 2009 for 100% of construction costs with a \$400,000 maximum.

ADDITIONAL INFORMATION:

A number of transportation related projects were submitted to and approved by the Des Moines Area Metropolitan Planning Organization Executive Committee at their January 29, 2009 meeting for funding under the American Recovery and Reinvestment Act of 2009. The funding request for McKinley Avenue resurfacing from South Union Street to Fleur Drive was approved. The Iowa Department of Transportation prepared an agreement for the proposed improvement, which was approved by the City Council on April 6, 2009, by Roll Call Number 09-518. This project consists of milling the existing roadway and resurfacing with HMA. The receipt of this and other transportation stimulus funds has allowed an acceleration of street projects. The local share of transportation stimulus funds must be from existing street CIP funds.

On July 13, 2009, under Roll Call No. 09-1183, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the McKinley Avenue

Resurfacing - Fleur Drive to South Union Street. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of contract documents and engineer's estimate for the construction of the McKinley Avenue Resurfacing - Fleur Drive to South Union Street, 06-2009-011. The improvement includes construction of 2" thick pavement scarification and HMA overlay, pavement markings, and other incidental items; in accordance with the contract documents, including Plans File Nos. 503-003/017, on McKinley Avenue from 350' east of Fleur Drive to 200' west of South Union Street, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders:

OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, Des Moines, IA Grimes Asphalt & Paving Corp., Grimes, IA

The bids, in accordance with a previously approved Iowa DOT Agreement, were received and opened by the Iowa DOT on July 21, 2009.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, James Gauger, President, 5550 NE 22nd Street, P.O. Box 3365, Des Moines, IA, 50316-0365 in the amount of \$339,405.16, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
