AGENDA HEADING:

Hearing on S.E. 5th Street Resurfacing - E. County Line Road to E. Army Post Road: Resolution approving plans, specifications, form of contract documents, engineer's estimate, receive and file bids, and designating lowest responsible bidder as Grimes Asphalt & Paving Corp., J M Yonker, President, \$467,340.08.

SYNOPSIS:

This is a public hearing to allow for public input on the S.E. 5th Street Resurfacing - E. County Line Road to E. Army Post Road and take the necessary actions as required by Iowa Code to authorize a contract for construction of the proposed project. On April 6, 2009, the City Council approved an Iowa Department of Transportation Agreement for Federal Stimulus project funding under the American Recovery and Reinvestment Act of 2009 for 100% of construction costs to a maximum amount of \$580,000 for S.E. 5th Street Resurfacing from E. County Line Road to E. Army Post Road which includes base repairs and street resurfacing with hot mix asphalt.

FISCAL IMPACT:

Amount: \$467,340.08 Construction Contract (\$530,000 City Engineer's Estimate)

<u>Funding Source</u>: 2009-2010 CIP, Page Street-32, Rehabilitation and Preservation of Major Roadways, STR222, Being: \$467,340.08 in Federal Stimulus Funds from the American Recovery and Reinvestment Act (ARRA) of 2009 for 100% of construction costs with a \$580,000 maximum.

ADDITIONAL INFORMATION:

A number of transportation related projects were submitted to and approved by the Des Moines Area Metropolitan Planning Organization Executive Committee at their January 29, 2009 meeting for funding under the American Recovery and Reinvestment Act of 2009. The funding request for S.E. 5th Street Resurfacing from E. Army Post Road to E. County Line Road was approved. The Iowa Department of Transportation prepared an agreement for the proposed improvement, which was approved by the City Council on April 6, 2009, by Roll Call Number 09-519. This project consists of base repair and preparation of the existing roadway and resurfacing with hot mix asphalt.

On July 13, 2009, under Roll Call No. 09-1184, the City Council received and filed plans, specifications, form of contract documents, and City Engineer's estimate for the construction of the S.E. 5th Street Resurfacing - E. County Line Road to E. Army Post Road. Before the City Council can enter into a contract, it must hold a public hearing and approve the proposed plans, specifications, and form of

contract documents and engineer's estimate for the construction of the S.E. 5th Street Resurfacing - E. County Line Road to E. Army Post Road, 06-2009-012. The improvement includes construction of an HMA overlay of 3" thickness, curb repair, patching, intake repair, pavement markings, restoration, and other incidental items; in accordance with the contract documents including Plan File Nos. 504-009/025 on S.E. 5th Street from E. County Line Road to E. Army Post Road, Des Moines, Iowa.

Sealed bids for said improvement were submitted by the following bidders: Grimes Asphalt & Paving Corp., Grimes, IA OMG Midwest, Inc. d/b/a Des Moines Asphalt & Paving, Des Moines, IA

The bids, in accordance with a previously approved Iowa DOT Agreement, were received and opened by the Iowa DOT on July 21, 2009.

The City Engineer has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Grimes Asphalt & Paving Corp., J M Yonker, President, 12021 NW 54th Avenue, Grimes, IA, 50111 in the amount of \$467,340.08, and said bid should be accepted. The Finance Director has determined that funds are available for said improvement as stated above.
