AGENDA HEADING:

Receive and file Urban Design Review Board approval and Riverwalk update.

SYNOPSIS:

Recommend receiving and filing the Urban Design Review Board approval of the Court Avenue Kiosk Building and update to Principal Riverwalk project status. There are no further City Council actions required for this project construction since the City entered into the Project Partnership Agreement on November 19, 2007, by Roll Call 07-2267. The project has been reviewed and approved by the City's Urban Design Review Board and Access Advisory Board.

FISCAL IMPACT:

Amount: No fiscal impact on this action, however, the estimated total project cost is \$60 million

<u>Funding Source</u>: Project costs that are administered through the City of Des Moines are included in 2009-10 CIP, Page Park Improvements-23, Riverwalk, PKS162. Project costs administered by the Corps of Engineers and entirely private dollars are not included in the CIP.

ADDITIONAL INFORMATION:

Construction of the Principal Riverwalk began in 2004. The completed project components include: Meredith Trail, Des Moines Union Railway Bridge renovation (a.k.a Red Bridge), Long Look Garden, Brenton Skating Plaza, and the Hansen Triangle. The Des Moines River Outfall and Overflow project included construction of the sewer and placement of sheetpile in place of the levee on the west side of the Des Moines River. The Center Street Pedestrian Bridge construction is expected to be completed later this year. Costs to date total approximately \$40 million.

Approximately \$11 million of construction projects is planned for 2009 and 2010 including: Walnut Street to Grand Avenue on the west side with Department of Transportation Federal stimulus funds; Court Avenue Plaza and Kiosk building with an option for the west side north of Grand Avenue using Corps of Engineers Greenbelt funding from FY08, FY09 and anticipated FY10 appropriations; East end of Center Street Bridge and Floodwall funded by I-Jobs, State Recreation Trails and City funds. The Court Avenue Plaza and Kiosk Building will be part of a Corps of Engineers construction project.

The Principal Riverwalk project has been very successful in obtaining Federal, State and private dollars. However, there is approximately \$11 million of Riverwalk projects to be funded, including: plaza and trail connections south of Court Avenue at the ends of the Des Moines Union Railway Bridge, promenade and plaza adjacent to the U.S. Courthouse, promenade adjacent to the Armory and Brenton

Skating Plaza, trail and pedestrian crossings at the west end of the Center Street Bridge (currently an option in the Corps project) and promenade adjacent to the existing YMCA.
