# **AGENDA HEADING:**

Approval of the lease of an irregular shaped portion of the sidewalk that is 654.25 square feet in size located in front of 310 Court Avenue, Spaghetti Works Restaurant, for use as a sidewalk café serving alcohol.

## SYNOPSIS:

The applicant, Shelly Stokes, president of I-80 SPAGHETTI WORKS CORP., located at 310 Court Avenue, has requested the re-lease of an irregular shaped portion of the Right of Way (654.25 sq ft) for use as a sidewalk café serving alcohol. The area has previously been vacated on June 27, 1988 by ordinance 11,194 and last leased to the adjacent property by the City Council on May 23, 2005 by Roll Call 05-1293.

FISCAL IMPACT: Increase in revenue to the City for the lease of the vacated right of way.

<u>Amount:</u> \$851.15 per year lease fee for three years paid to the City or \$2,553.44 for 3 years

## **ADDITIONAL INFORMATION:**

The Design Standards for Sidewalk Cafés were adopted by the City Council on July 10, 2006, by Roll Call No. 06-1360. This area was last approved for use as a sidewalk café on May 23, 2005 by Roll Call 05-1293. This area has been used or leased as a sidewalk café continuously since 1988. This area meets all current requirements for sidewalk cafés serving alcohol. All required lease fees have been paid.
