T.M. Franklin Cownie (R-2) Mayor, to Washington, D.C., on September 15, 2009 (\$1,321), to attend a meeting with Senate Staff and Administration on an energy grant (Tiger Grant).

Brian Dennis (R-0) FSS Coordinator, to Chicago, IL, from September 19 – September 23, 2009, (\$1,318), to attend the 2009 National Service Coordinator Conference.

Jeff Morton (NR-0) Senior Police Officer, to San Diego, CA, from November 15 – November 21, 2009, (\$2,277.41), to attend the Foundations of Intelligence Analysis Training, a five day introduction to the basics of law enforcement intelligence analysis that meets the certification requirements of the grant funds.

Douglas Philiph (R-0) Assistant City Attorney, to Denver, CO, from October 2 – October 6, 2009, (\$2,190), to attend the IACP Annual Conference. Included in this training is the Legal Officers Section Seminar which allows the attorney to keep current on legal and other issues affecting law enforcement.

Robin Sprafka (NR-0) Sergeant, to Omaha, NE, from October 25 – November 6, 2009, (\$1,628), to attend the Mounted Patrol Instruction Certification course.

Paul Stout (NR-0) Lieutenant, to Evanston, IL, from October 25 – October 30, 2009, (\$1,926), to attend a Crime Scene Technology Course. The course provides training in crime scene assessment, a variety of chemical processes used in evidence processing and gathering, and legal issues of evidence.

Michael Towey (R-1) Human Rights Specialist, to Washington D.C., from October 25 – October 31, (\$2,189), to attend the National Fair Housing Training Academy. This is the second week of five weeks of training required by the U.S. Department of Housing and Urban Development (HUD).

Thomas Vlassis (R-0) Council Member, to Muskegon, MI, from September 22 – September 26, (\$850), to attend the National League of Cities Conference, including a meeting of the CED Steering Committee.

The amount budgeted for travel in Fiscal Year (FY) 2010 is \$629,436. The amount expended for travel in FY 2010, as of September 4, 2009, is \$56,177.
