AGENDA HEADING:

Public Hearing and Resolution of Necessity on Proposed Final Connection Fee Ordinance for the Clover Hill Trunk Sanitary Sewer System Benefited District.

SYNOPSIS:

Public Hearing on Final Connection Fee Ordinance for the Clover Hill Trunk Sanitary Sewer System Benefited District.

FISCAL IMPACT:

<u>Amount</u>: The fiscal impact cannot be calculated at this time for two primary reasons. One, it is not know how many acres may be used in a specific development and two, it is not known how many years out a development may connect to the system. These two variables will determine the actual fiscal impact of this change.

ADDITIONAL INFORMATION:

On April 25, 2005 by Roll Call No. 05-1009, the City Council established a Connection Fee Ordinance for the Clover Hill Trunk Sanitary Sewer System Benefited District. The estimated cost to design and construct the Clover Hill Area Trunk Sanitary Sewer was \$1,501,354. There are 440.25 acres within the proposed Clover Hill Area Trunk Sanitary Sewer Benefited District, which equated to a \$3,410.23 connection fee for each benefited acre. Ordinance No. 13,038 requires property owners to be within the corporate limits of the City of Des Moines in order to be eligible for connection to the sanitary sewer. As a result of the recent involuntary annexation, effective June 26, 2009, the entire benefited district is now within the City of Des Moines.

The Clover Hill Trunk Sanitary Sewer was constructed in two phases. Phase 1 construction began at a point on an existing Wastewater Reclamation Authority (WRA) Interceptor sewer near the southeast corner of Highway 5 and County R63 Highway (SW 9th Street alignment), and proceeded northeasterly across Highway 5. Phase 2 construction began at a point on an existing WRA Interceptor sewer near the southwest corner of Highway 5 and County R63 Highway and proceeded northwesterly across Highway 5.

The final cost to design and construct the Clover Hill Area Trunk Sanitary Sewer was \$1,219,953.66. There are 440.25 acres within the proposed Clover Hill Area Trunk Sanitary Sewer Benefited District,

which equates to a \$2,771.05 connection fee for each benefited acre. The connection fee for each benefited acre was reduced by \$639.19 due to the lower construction costs then estimated. The proposed Final Connection Fee Ordinance also provides for the collection of interest at the rate of 5% per annum, simple interest on said connection fee, and establishing of a connection fee schedule reflecting an annual interest adjustment of the connection fee amount. The 5% interest rate approximates the City's current cost of financing.

On July 27, 2009 by Roll Call No. 09-1320, the City Council set the date of September 14, 2009 for a public hearing to be held on the proposed resolution of necessity and amendment of the connection fee ordinance for the Clover Hill Trunk Sanitary Sewer System Benefited District. The owners of properties within the Clover Hill Trunk Sanitary Sewer Benefited District, or any other person having an interest in said matter, may appear and be heard for or against the total cost of the improvement, or the proposed reduction of the connection fee.
