AGENDA HEADING:

Approval of the 2009 U.S. Department of Housing and Urban Development (HUD) Continuum of Care Application.

SYNOPSIS:

Recommend Council approval to submit the 2009 Supportive Housing Program application for Continuum of Care and Shelter Plus Care funding.

Funding Source: 2009 HUD Supportive Housing Program (SHP) for Continuum of Care and Shelter Plus Care funding.

ADDITIONAL INFORMATION

At their meeting on June 22, 2009 by Roll Call No. 09-1082 (Council Communication No. 09-398) the City Council adopted the Polk County Housing Continuum’s (PCHC) recommendations for procedures and priorities to be used in development of the 2009 SHP application. The PCHC has forwarded a communication stating that these procedures and priorities were followed in preparing the application and lists the renewal, bonus, and Shelter Plus Care projects to be included in the 2009 application. The City manager has reviewed this information and recommends approval of the application.
