AGENDA HEADING:

Authorizing the City of Des Moines Municipal Housing Agency to submit proposed payment standards for the Section 8 Housing Choice Voucher program to the U.S. Department of Housing and Urban Development.

SYNOPSIS:

Recommend approval to revise and submit the proposed payment standards for the Section 8 Housing Choice Voucher program to the U.S. Department of Housing and Urban Development (HUD).

ADDITIONAL INFORMATION:

The Des Moines Municipal Housing Agency (DMMHA) is required by the U.S. Department of Housing and Urban Development (HUD) to establish payment standards by bedroom size for the Section 8 Housing Choice Voucher program. Further, the Federal regulations require that Housing Agencies review their payment standards annually. The payment standard is used to calculate the monthly housing assistance payment for a family under the Section 8 Housing Choice Voucher program. The range of possible payment standard amounts is based on HUD's published fair market rent (FMR) schedules.

The current payment standards represent 89-104% of the FMRs and are not within the HUD guidelines (payment standards must be between 90% and 110% of the FMRs). DMMHA has conducted a review of the current payment standards and the zero bedroom payment standard must be raised by one (1) dollar. DMMHA has reviewed the success rates for current Section 8 Voucher program participants in finding affordable housing and the rent burdens of current participants and found these two factors to be within acceptable Federal payment standard guidelines.

DMMHA proposes to revise only the zero bedroom payment standard from \$455 to \$456 and leave the other bedroom payment standards as they are.
