## AGENDA HEADING:

Approval of Scope of Work submitted by Intergraph Corporation 170 Graphics Drive, Madison, Alabama for the Police Department Pawn Shop Interface to I/Leads Record System.

## SYNOPSIS:

Recommend approval to accept the Statement of Work submitted by Intergraph Corporation to install a Pawn Shop Interface to the Police I/Leads record system and to authorize the Mayor of the City of Des Moines to sign said Statement of Work and to have the City Clerk attest to his signature.

## ADDITIONAL INFORMATION:

The Police Departments Criminal Investigation Bureau has for many years realized the importance of monitoring pawn shop transactions in the City. The utilization of these records is instrumental in locating and confiscating stolen property pawned by suspects. For many years, this information data base was housed in the IT Department's main frame computer. After the City eliminated the main frame system, the data was gathered and entered into a PC data base format. The pawn shop data is now housed in a web-based data entry application.

The Police Department currently employs a computerized records management system called I/Leads. This system has incorporated a majority of the department's record information and it is the desire of the staff that the pawn shop data base be incorporated into this data base. The I/Leads System is a product of Intergraph Corporation. This is a sole source application and requires an interface that only Intergraph can provide.

The Police Department and the City Procurement Director who confirms the Municipal Code Section 2-726 (a)(7) provides for a non-competitive procurement of goods and/or services that are of such a nature that they are the only goods and/or services which will fit and comply with the required use, or are an integral part of a total system so as to be uniquely compatible with existing city needs, materials or equipment to be cost effective, that this Statement of Work be approved.
