## SYNOPSIS:

## **ADDITIONAL INFORMATION:**

The pump at the Birdland Sanitary Lift Station that performs a majority of the pumping at the station failed and required timely replacement. The Department of Public Works' Sewer Enterprise Division has been advised the replacement pump has been installed at the price established in the approved purchase contract with Electric Pump & Tool Services Inc., per Roll Call No. 08-2138, dated December 8, 2008.

The replacement pump and related equipment was obtained and installed at the approved contract price prior to first providing the information to the Procurement Division in order to obtain City Council authorization to procure the pump and related equipment at the price established in the approved purchase contract. The Department of Public Works' Sewer Enterprise Division is requesting City Council to approve this procurement of pumps and related equipment for the Birdland Sanitary Lift Station from Electric Pump & Tool Services Inc. and authorize the Finance Department to issue payment.
