### **AGENDA HEADING:**

Hearing and Adoption of Proposed Municipal Housing Agency Annual Budget for the Fiscal Year Ending June 30, 2011.

### **SYNOPSIS:**

The Des Moines Municipal Housing Agency (DMMHA) seeks Governing Board approval of its proposed annual budget for the fiscal year ending June 30, 2011.

### **FISCAL IMPACT:**

Amount: Annual budget in the amount of \$20,965,936.

<u>Funding Source</u>: U.S. Department of Housing and Urban Development. Proposed FY 2011 Recommended Operating Budget, pgs. 133-143.

The DMMHA's annual budget is recommended to be appropriated as follows:

The Section 8 program continues to be the most popular program for our clients. The Des Moines Municipal Housing Agency (DMMHA) last opened the waiting list in December 2008 and received 3,188 applications. Currently, over \$1,100,000 per month in Housing Assistance Payments is paid to landlords in the community.

The Public Housing program will continue to be reducing its public housing inventory. This will be done by the sale of property through our 5h Homeownership Program and the approved disposition of scattered-site housing units. Investments in the 5 manors (390 units) will continue throughout the fiscal year.

Additionally, a staff reduction of 3.5 full time equivalent employees is included in the proposed budget.
