ADDITIONAL INFORMATION:

The Des Moines Municipal Housing Agency (DMMHA) is required to submit a Management Operations Certification to the Real Estate Assessment Center (REAC) for use in scoring under the Management Assessment Sub-System (MASS) certification to HUD by March 13, 2010. The certification is used to evaluate the performance of the Public Housing program in significant areas of management operations.

The certification includes the following indicators:

- Vacant Unit Turnaround Time
- Capital Fund
- Work Orders
- Annual Inspection of Dwelling Units & Systems
- Security
- Economic Self-Sufficiency

Upon approval by the Governing Board, the Management Operations Certification will be submitted to HUD. HUD will score the certification and notify the DMMHA of the results.
